## Installed Software

This release of Aras Innovator supports the use of Chrome 60 (minimum).

## Required Settings

You may need administrative rights to disable the Pop-up blocker using the following procedure:

1. Open a new Chrome window and select **Settings**.
2. Scroll Down and select **Advanced**.
3. Select the **Content settings** bar.
4. Select **Popups**.
5. Go to **Allow** and click **Add** to add the Aras Innovator URL.



Aras PDF Viewer is a feature included in Aras Innovator to display PDF documents as part of the Visual Collaboration feature. The technology used to make the feature display PDFs is browser-specific. Users may experience differences in behavior when loading in Internet Explorer vs FireFox or Chrome. While all browsers provide the same functionality, the user experience will be slightly different.
