# 1 Client Configuration

## 1.1 Installed Software

Starting with version 11.0 SP6, Aras Innovator supports the use of Chrome Browser.

## 1.2 Required Settings

The following steps may require administrative rights to complete.

1. Disable Pop-up blocker.
  - a. Open a new Chrome window and open **Settings**.
  - b. Under **Advanced --> Privacy** section, click the **Content settings...** button.
  - c. For **Pop-ups**, click **Manage exceptions...** button
  - d. Add the Aras Innovator URL and set it to **Allow** Behavior.

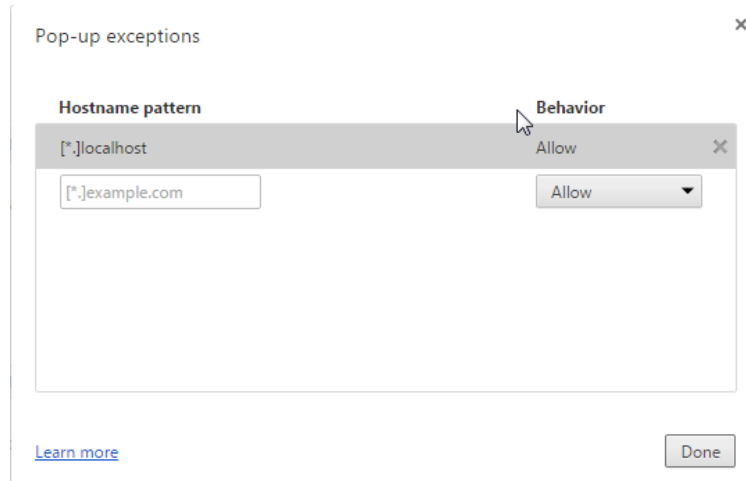

2. Restart the Chrome Browser before attempting to load the login screen.

## 1.3 Note about Aras PDF Viewer

Aras PDF Viewer is a feature included in Aras Innovator to display PDF documents as part of the Visual Collaboration feature. However, the technology used to make feature display PDFs is browser specific. Users may experience differences in behavior when loading in Internet Explorer vs FireFox or Chrome. While all browsers provide the same functionality, the user experience will be slightly different.
