### 1 Overview

This document provides detailed instruction for the installation of the Aras Update. The steps detailed in this document are intended to allow a novice administrator to install the Aras Update. However, more general knowledge of system administration, network deployment, and Aras Innovator administration is recommended.

### 1.1 Prerequisites

Aras Update tool should be installed on the same machine as Aras Innovator. Before installing Aras Update tool, confirm that .NET 4.5 is installed on this machine.



## 2 Installing Aras Update

1. Launch the ArasUpdateSetup installer.

2. Click the "Next >" button.



3. Review the License agreement. Click the "I accept the terms in the license agreement" option and then click the "Next" button to install.



4. Click the "Change..." button to select a new installation directory (as appropriate). Click the "Next >" button.



5. Click the "Back" button to change the installation directory (as required). Click the "Install" button to start the installation process.



6. Click the "Finish" button to close the installer.




### 3 Troubleshooting

If you have an earlier version of Aras Update installed and you run the Aras Update installer, then you will see the following error message:



To resolve this, un-install the earlier version of Aras Update and then run the installer msi file again.
