2 Enhancements, Bug Fixes, and Known Issues

2.1 Enhancements in Aras Office Connector 14

Property Redirection for authoring_tool Property

Administrators can now use Property Redirection to redirect Aras Office Connector to an alternative property for authoring_tool if the authoring_tool property is already in use by another application or connector.

Progress Indicator for Aras Office Connector Actions

Progress Indicators have been implemented to communicate Aras Office Connector actions that are in progress. Progress Indicators have been added when refreshing Aras Office Connector configuration settings, and when adding/removing links to Aras Innovator items.

2.3 Known Issues in Aras Office Connector 14

Issue #	Description	Workaround
I-012323	Aras Office Connector can be installed in Microsoft Visio 2013 without any visible errors even though Visio 2013 is not supported.
